Volunteerism provides youth, families and groups to experience the Mam-Maya culture and to serve in critically under-resourced communities in Guatemala. These experiences are both guided (pre-arranged by Xela AID staff) and independent (self-led), each incorporating experiences and activities that promote cultural understanding and personal growth. These volunteers not only enrich our Guatemalan communities and benefit from personal enrichment, but they often go on to serve within the organization as return volunteers, program supporters, committee members and Board members. Thus, volunteerism is core to our mission.
